- •Engineer report on file from JHA
  - 1. Change order 2 in the amount of \$11,851.59 has been partially paid by GTSA in the amount of \$4,622.32. The remaining balance has been denied to PSI for payment.
  - 2. Change order 3, which is for additional piping work, JHA has denied in totality.
  - 3. PSI had better pricing on 2 30kw generators. It is recommended that you purchase them from PSI.
  - 4. Motion to approve Change order 4 for \$50,582.41 for 2-30kw generators from PSI by Graziano, 2<sup>nd</sup> Bonczkiewicz all in favor.
  - 5. Motion to approve PSI change order #5 in the amount of \$1,632.38 by Graziano 2<sup>nd</sup> Bonczkiewicz, all in favor.
  - 6. 2 violations from DEP in May for effluent limit violation.
  - 7. JHA received a call from Justin Ford SEO regarding a complacent property in the township that has solidified sewage in drums from backup in the home. He inquired about using a GTSA pump truck to collect and dispose of the drums' contents. JHA is against getting involved in nonservice work.
  - 8. Hunter Snyder contacted JHA regarding connection requirements for 6-8 parcels off Grouse Hill Road. JHA advised that the system does have capacity. A sewer extension would require an application to DEP and the sewage facilities module.
  - 9. Motion to accept Engineer's report as presented by Graziano 2<sup>nd</sup> Bonczkiewicz, all in favor.

1. Motion to have Xylem test vapor data at the pump stations and plant for odor control by Shifler 2<sup>nd</sup> Bonczkiewicz

2. Melissa Graziano received a complaint from a resident of Greenfield Twp.: There was sewage in barrels outside of the home. This home isn't on the sewage system. The problem was referred to Justin Ford, SEO, and Nick Bonczkiewicz, supervisor.
